# 32<sup>nd</sup> EBM RESOLUTIONS 9<sup>th</sup> DECEMBER 2019 SOKHA HOTEL, PHNOM PENH CAMBODIA

# PROGRESS REPORT ON THE RESOLUTIONS ADOPTED DURING THE 32<sup>nd</sup> EXECUTIVE BOARD MEETING

The Resolutions and the progress reports are as follows:

# RESOLUTION 19-1: SAFEGUARDING AND PRESERVATION OF MILITARY HISTORICAL EVENTS

**Referring:** to the recommendation of the Resolution 17-3 of the 17<sup>th</sup> GA, each VECONAC country member has taken appropriate actions.

**Recognising:** the actions of Historic military sites and events of the VECONAC member countries should be compiled.

#### **Hereby Resolved:**

Each VECONAC member is recommended to submit a minimum of two historical / military sites and events to the secretariat by the 20<sup>th</sup> GA in Vietnam. The list will be uploaded on the VECONAC website.

### **RESOLUTION 19-2: RESOLUTION ON DOMICILLING VECONAC ACCOUNT**

**Referring:** to the Resolution 18-2 of the 18<sup>th</sup> GA on the need of domiciling VECONAC Account in one country with the purpose of cost saving in term of commission charged by the bank.

**Noting:** that after further study on the viability of the matter, there are two recommended options for consideration:

- 1. Option One: To appoint one VECONAC Member Country to function in domiciling the VECONAC Account in one of the registered banks in its country.
- 2. Option Two: To allow the VECONAC Fund to be kept in cash if Option One cannot be implemented due to the imposing Banking Regulation and Procedures.

#### **Hereby Resolved:**

The 19<sup>th</sup> GA has elected to adopt Option 2 of the above recommendation for implementation.

# RESOLUTION 19-3: RESOLUTION TO DEVELOP A VISION AND MISSION STATEMENT OF VECONAC

**Referring:** to the Resolution 18-3 of the 18<sup>th</sup> GA on the need to develop a Vision and Mission Statement of VECONAC.

## **Hereby Recommended:**

The proposed Vision and Mission together with the Motto and Core Values of the VECONAC is as stipulated at Annex 'A' to Resolution 19-3 to be considered and adopted by the 19<sup>th</sup> GA.

# RESOLUSION 19-4: RESOLUTION ON THE ESTABLISHMENT OF PERMANENT BUREAU WITHIN THE VECONAC ENTITY

**Referring:** to the Resolution 18-6 of the 18<sup>th</sup> GA to establish the Permanent Bureau within the VECONAC entity.

**Noting:** that after a further viability study, the Bureau cannot be established due to financial and administrative implications to the VECONAC.

## **Hereby Recommended:**

The resolution to be dropped.

# RESOLUTION 19-5: RESOLUTION ON APPOINTING LVRI AS THE COORDINATOR AND LINK BETWEEN VECONAC AND ASEAN SECRETARIAT

**Referring:** to the Resolution 18-6 of the 18<sup>th</sup> GA to establish the Permanent Bureau within the VECONAC entity.

**Noting:** that after a further viability study, it was identified that the Bureau cannot be establish because its implementation will incur financial and administrative implications to the VECONAC.

## **Hereby Recommended:**

It is proposed that LVRI to be appointed and designated as a Coordinator and Link between VECONAC and ASEAN Secretariat. This will be formalized by a memorandum from VECONAC Secretariat to that effect. VECONAC member countries are encouraged to attend ASEAN organized events as and when informed by LVRI.

# RESOLUTION 19-6: THE ESTABLISHMENT OF AN ECONOMIC BUREAU WITHIN THE VECONAC ENTITY

**Referring:** to the Resolution 31-10 of 31<sup>st</sup> EBM and the discussion during Working Committee Meeting on 04<sup>th</sup> July 2019.

### **Hereby resolved:**

To defer the establishment of an Economic Bureau within the VECONAC entity due to some constraints.

RESOLUTION 19-7: AWARDING THE VECONAC HONORARY PRESIDENCY TITLE AND VECONAC MEDAL OF HONOUR TO VETERANS ASSOCIATION OF ROYAL BRUNEI ARMED FORCES (VARBAF)

**Referring:** to the Draft Resolution of the Working Committee 2019, awarding the VECONAC Honorary Presidency title and VECONAC Medal of Honour to Veterans Association of Royal Brunei Armed Forces (VARBAF).

**Acknowledging:** that a circular has been sent and approved by all Vice-Presidents of VECONAC for the endorsement of the award to HE PEHIN DATU PADUKARAJA MAJOR GENERAL (RETD) DATO PADUKA SERI HAJI SHARI BIN AHMAD to be conferred the titled VECONAC Honorary Presidency and LIEUTENANT COLONEL (RETD) RAMLI BIN ABD HADIS to be awarded the VECONAC Medal of Honour.

## **Hereby Recommended:**

The 19<sup>th</sup> GA retrospectively approve the award of VECONAC Honorary Presidency title and VECONAC Medal of Honour.

#### **RESOLUTION 19-8: INCREMENT OF ANNUAL DUES**

**Noting:** that the last increment of VECONAC DUES was done in 2016 and the business costs and inflation have risen.

**Considering:** that VECONAC has to bear the higher cost of organizing these activities.

## **Hereby Resolved:**

The Annual Dues is recommended to be increased from USD600.00 to USD1,000.00.

# RESOLUTION 19-9: DRAFT RESOLUTION TO AWARD THE VECONAC HONORARY PRESIDENCY TITLE AND VECONAC MEDAL OF HONOUR

**Noting:** that the LAO VETERANS FEDERATION (LVA) has successfully organised and executed the 31<sup>st</sup> EBM and 18<sup>th</sup> GA.

#### **Hereby Recommended:**

The recommendation for HE BRIGADIER GENERAL (RETD) SOMPHON KEOMIXAY to be conferred the title VECONAC Honorary Presidency and LIEUTENANT COLONEL (RETD) KHAMSING SOSENGINH to be awarded the VECONAC Medal of Honour.

# RESOLUTION 19-10: DRAFT RESOLUTION FOR AWARD OF VECONAC HONORARY PRESIDENCY TITLE AND VECONAC MEDAL OF HONOUR TO PAST HOST COUNTRIES

**Acknowledging:** that past host countries who had successfully organised and executed the EBMs and GAs, but have not been duly recognised.

### **Hereby Recommended:**

All VECONAC member countries to submit deserving appointment holders to EBM for Award considerations.

#### **RESOLUTION 19-11: FINANCIAL REPORT AND BUDGET ESTIMATION**

**Referring:** to the discussion during Working Committee Meeting on 04<sup>th</sup> July 2019 to have budget estimation of VECONAC annually.

**Recognizing:** that it is necessary for the VECONAC budget estimation to be endorsed.

#### Hereby resolved:

Treasurer General is to table the financial report of recent year together with budget estimation for coming year to be endorsed.

# RESOLUTION 19-12: THE CERTIFICATES OF APPRECIATION TO THE PRESIDENT, SECRETARY GENERAL AND TREASURER GENERAL OF THE HOST COUNTRY

**Referring:** to the discussion and recommendation during the Working Committee Meeting on 04<sup>th</sup> July 2019 to present Certificates of Appreciation to the host country.

**Acknowledging:** that it will be more appropriate to present the Certificates of Appreciation to the President, Secretary General and Treasurer General of the host country for their achievement.

### Hereby resolved:

The GA is to present the Certificates of Appreciation to the President, Secretary General and Treasurer General of the previous and present host countries.

#### **RESOLUTION 19-13: APPRECIATION TO THE HOST COUNTRY**

**Noting:** that the 32<sup>nd</sup> EBM Working Committee Meeting has been arranged and conducted in a very harmonious and peaceful environment by the host association.

**Considering:** that the host association has put up a lot of effort in making the 32<sup>nd</sup> EBM Working Committee Meeting a success.

#### **Hereby Resolved:**

Highly appreciate and thank the Cambodian Veterans Association (CVA) for successfully hosting the 32<sup>nd</sup> EBM Working Committee Meeting in Sokha Siem Reap Resort, Siem Reap, and Kingdom of Cambodia.

# RESOLUTION 19-14: BILATERAL/MULTILATERAL COLLABORATION BETWEEN VECONAC MEMBER COUNTRIES

**Noting** that cooperation and exchange of views and expertise between countries has always benefitted Peace and Well-being of the region.

**Considering** that such bilateral/multilateral activities are already in place for several neighboring countries in ASEAN.

**Hereby Resolved** that such bilateral/multilateral collaborations be actively Pursued and Recorded as a permanent feature by all member countries of VECONAC.
