VECONAC 20TH GA RESOLUTIONS

RESOLUTION 20-1: RESOLUTION ON ADDING THE MEANING OF VECONAC FLAG TO THE VECONAC CONSTITUTION

Noting that participants attending the virtual VECONAC WCM on 21 October 2020 unanimously proposed to add the meaning of VECONAC Flag to the VECONAC Constitution.

Recognising that only the VECONAC Seal and Logo are depicted in the Constitution of the Confederation.

Hereby Recommended that the new VECONAC Secretariat is to draft the amendment to the Constitution and to table the draft for discussion at the Working Committee Meeting prior to the 34th EBM and the 21st GA, thereafter, to be submitted to the 34th EBM for recommendation and the 21st GA for adoption.

RESOLUTION 20-2: RESOLUTION ON COMMEMORATING THE VECONAC FOUNDING DAY ANNUALLY ON DECEMBER 19

Noting that VECONAC was founded on 19 December 1980 in Jakarta, Republic of Indonesia.

Recognising that since its inception, the Confederation has progressed strongly, making important contributions to the mutual understanding and welfare of its members, for peace, solidarity and prosperity in Southeast Asia.

Considering that the commemoration of its founding day annually helps to further enhance the identity and prestige of VECONAC, and cement the bond among members of the Confederation.

Hereby Recommended that members of the Confederation will commemorate the VECONAC founding day annually on December 19.

RESOLUTION 20-3: RESOLUTION ON CALAMITIES AFFECTING THE HOLDING OF VECONAC MEETINGS

Recognising that calamities have disrupted many lives, livelihoods and events including the holding of VECONAC meetings.

Hereby Recommended that the new VECONAC Secretariat is to draft the Resolution and to table the draft for discussion at the Working Committee Meeting prior to the 34th EBM and 21st GA, and thereafter, to be submitted to 34th EBM for recommendation and the 21st GA for adoption.

RESOLUTION 20-4: RESOLUTION TO RECONFIRM THE ROTATIONAL SYSTEM OF VECONAC CHAIRMANSHIP

Noting that due to the complicated developments of the COVID – 19 pandemic, the Veterans Association of Vietnam (VAVN) was unable to hold the face – to – face 33rd Executive Board Meeting and the 20th General Assembly in 2020. In this regard, all VECONAC member countries agreed to postpone the VECONAC meetings, hence, the VAVN has continued to hold the VECONAC Presidency through 2021;

Recognising the significance for member countries to have an equal opportunity to host VECONAC Executive Board Meeting and General Assembly;
